The Blue Bird Circle Shop (the "Shop") accepts consignment furniture and household by appointment. One consignment per account is accepted every thirty (30) days, one trip only. Only two (2) accounts per household using the same address are allowed. Consignments must meet the following requirements:

Consignments must meet the following requirements:

- Consignor must list each item that constitutes a consignment
- Items must be in good condition, clean, no stains or broken parts and free of animal hair and tobacco odors
- Each item in the consignment must be priceable for at least \$7.00, if not, the item becomes a donation.
- A total consignment value of at least \$50.00

PLEASE SEE THE FURNITURE CONSIGNMENT REQUIREMENTS FOR SPECIFICS ON ACCEPTABLE CONSIGNMENTS.

Consignor agrees that it is the exclusive right of the Shop:

- to determine if the items brought to the Shop by a consignor meet the Shop's requirements for sale in the Shop.
- to determine the price of all items in consignments.
- to determine the Shop's markdown policy.
- Furniture consignments expire ninety (90) days from the date the consignment was priced.
- Seasonal consignments expire sixty (60) days from the date the consignment was priced.
- After ninety (90) days the item becomes property of The Blue Bird Circle.
- Consignor will be paid 60% of the selling price of all items sold during the contract period and will be paid by mailed checks only.
- There is a \$10.00 minimum on consignment checks; lesser amounts may accumulate and pay at a later date.
- A \$2.00 processing/handling fee per check will be deducted from each consignor check issued.
- There will be a \$7.00 replacement fee for misplaced or unreceived check. The replacement waiting period is ninety (90) days from issue date.
- Checks uncashed after one (1) year of the date of issuance will not be replaced but will be treated as a "Shop" donation.
- If a party other than the consignor delivers a consignment, it will not be accepted without a signed contract and a complete list of items.

The consignor agrees that any consigned items that cannot be priced by the Shop or those items that have not sold within the dating period of a contract will automatically, and with no notice to the consignor, become items irrevocably donated by the consignor to the Shop, and the consignor will have no further interest in such donated items.

The consignor agrees and acknowledges the Shop, The Blue Bird Circle and its officers, directors, agents, employees, and volunteers, assume no responsibility nor liability for the loss or damage to the goods consigned to the Shop including, without limitation, any such loss or damage occasioned by negligence. **Authenticity Requirements: We do not accept counterfeit, replica or duplicate items for consignment or sale. Consignor warrants that all items submitted for consignment are authentic and accurately represented.**
